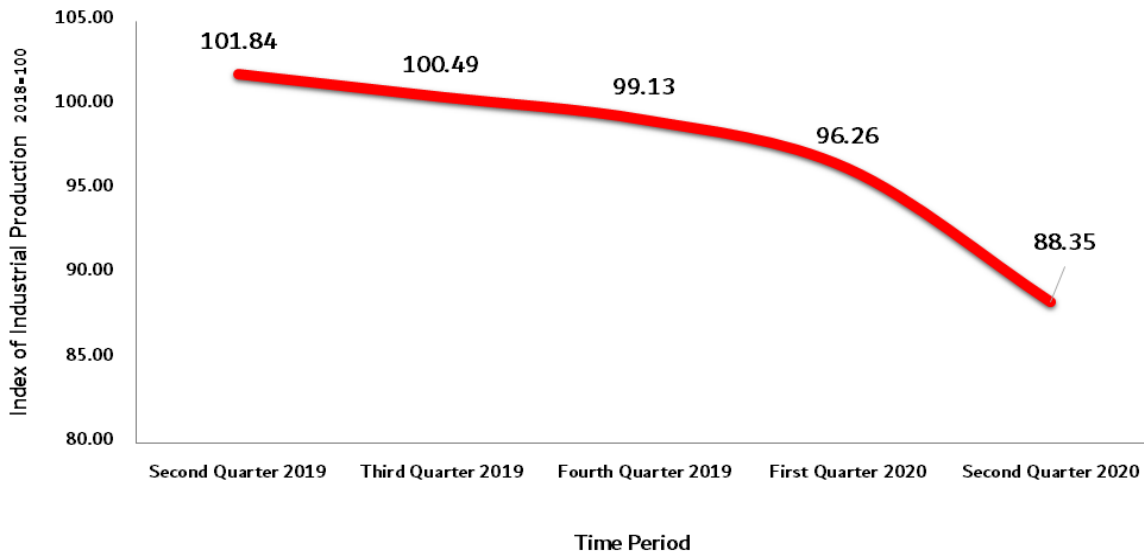
| Index of Industrial Production “Manufacturing Sector”

Second Quarter 2020 – Emirates of Dubai

The general index of industrial production for the manufacturing sector for the second quarter of 2020 recorded a decrease of 8.22% compared to the first quarter of 2020, and decrease of 13.24% compared to the second quarter of 2019.

| Movement of Industrial Production Index for manufacturing sector during Second Quarter 2020 compared to First Quarter 2020 (Quarterly change)

The index of industrial production for the manufacturing sector during the second quarter of 2020 recorded a decrease of 8.22% compared to the first quarter of 2020. This decline is due to a decrease in the production of refined petroleum products by 30.49%, chemicals and chemical products by 26.82%, other non-metallic mineral products by 24.92%, Wearing apparel by 23.62% printing and reproduction of recorded media by 23.55%, other manufacturing industries by 18.55%, paper and paper products by 16.25%, furniture by 14.96%, machinery and equipment n.e.c by 14.87%, wood, wood products and cork, except furniture by 12.12%, Fabricated metal products, except machinery and equipment by 11.79%, beverages by 10.60%, electrical equipment by 9.81%, textiles by 2.82%.

On the other hand, some industries recorded an increase in their production compared to the first quarter of 2020, as the production of leather and related products increased by 61.34% tobacco products by 15.56%, repair and installation of machines and equipment by 14.69% food products by 10.29%, rubber and plastics products by 8.00%, basic pharmaceutical products and pharmaceutical preparations by 7.69%, motor vehicles, trailers and semi-trailers by 4.98% and base metals by 2.89%.

While other transport equipment maintained its stability for the second quarter of 2020 compared to first quarter 2020.

| Movement of Industrial Production Index for manufacturing sector during second Quarter 2020 compared to second Quarter 2019 (Annual change)

The index of industrial production for the manufacturing sector during the second quarter of 2020-recorded decrease of 13.24% compared to the second quarter of 2019. This decline is due to a decrease in the production of Wearing apparel by 60.38%, other manufacturing industries by 42.62%, refined petroleum products by 33.36%, chemicals and chemical products by 33.00%, Motor vehicles, trailers and semi-trailers by 31.87%, Furniture by 31.14%, other non-metallic mineral products by 30.50%, Wood and products of wood and cork, except furniture by 22.69%, other transport equipment by 22.22%, printing and reproduction of recorded media by 16.69%, Fabricated metal products, except machinery and equipment by 14.86%, Beverages by 13.27%, rubber and plastics products by 9.19%, machinery and equipment n.e.c by 3.21%, repair and installation of machinery and equipment by 1.22% and textiles by 0.64%.

On the other hand, some industries recorded an increase in their production compared to the second quarter of 2019, as the production of basic pharmaceutical products and pharmaceutical preparations increased by 78.95%, food products by 34.29%, leather and related products by 31.82%, paper and paper products by 7.81% and Base metals by 3.66%, electrical equipment by 2.86% and tobacco products by 1.52%.
